ANNOUNCEMENT

General framework of the issues, purpose and objectives

Over the past two decades many countries have been confronted with what has been the phenomenon known generically by the term globalization phenomenon that has generated undoubtedly progress in the production field, economic and technological but in many cases had negative findings in the local scale. The speed and force of the changes generated also did not allow the necessary local adaptation, especially in those regions more marginal than in countries that are driving the dominant development model, just as the Mediterranean area, which are found not adequately equipped for these changes.

This situation has certainly exacerbated imbalances already very strong at the level of production and local knowledge and often led to the adoption of reference models "external" unrelated to the specific identity of the more marginal areas, so to make perception of our local values (especially in young people) as a value that does not affect significance when compared with international social and economic context that today runs the development.

This perverse mechanism is leading to a progressive weakening of the collective memory of the cultural heritage of many land and urban areas, a specific provision of real resources (increasingly set aside) to a general feeling of powerlessness in relation to local media if compared to trans-national market increasingly disconnected from the "place" physical and to an excessive "magnetism" exercised by large cities and coastal areas.

With the loss of full consciousness of our own heritage, they will fail the foundations of the value of place and this will inevitably lead to further pressures to abandon the native place to seek work and opportunities for growth "outside", thereby strengthening In this way, the phenomenon of depletion of internal areas and the congestion of coastal areas and large urban conurbations, worldwide.

The International Summer School 2010 is intended to identify those specific actions are possible, for the home, the city and the territory, which can help to combat the phenomenon of de-territorialization economy and abandonment of the place favouring, instead, the recovery of the territory through the development of the themes identified and that will be dealt with during training activities and application.

Problems, objectives and themes that were identified are intended to strengthen and consolidate confidence in their own resources and capacity within local communities and the growth of a form of social responsibility in the new (and future) generations through the enhancement and promotion of















sustainable development issues, with a view to real subsidiarity and active awareness of the actors involved.

The purpose that the establishment of the International Summer School intends to pursue is to realize a series of meetings, annually, to deal fully of the many facets that specifically identify the topics in question.

Objective of the International Summer School is to foster dialogue between universities Mediterranean, through the joint presence of teachers and students, so that participants can initiate an exchange of ideas and future visions and to share a field of experiences.

In this direction the training offer of the Summer School will feature intensive workshop aimed to overcome some urban and territorial projects, agreed in advance with the host local government and local actors in order to further operationalize the thematic treated by the scholars invited to present their speeches during the subsequent sessions of meeting.

Articulation of activities and formative curriculum:

Summer School activities are divided into two parallel training courses:

Path a): Shaping the shorelines areas - Cefalù

Path b): Shaping the inland areas - Petralia Soprana

The program of the Summer School takes place in five days of training and application activities that are closed with a final presentation of results. The formative curriculum is divided into classroom lectures and speeches, seminars and panel discussions, guided visits and laboratory exercises.

The first day is dedicated to the introduction on the general themes and specific objectives of both training and the division of participants into working groups. The next two days will be devoted to lectures, to round tables discussion on the proposed themes, guided tours and lab work in the classroom. The fourth will be a day dedicated to the laboratory.

Work done in the laboratory will be presented during the fifth and final day of activities and will conclude with a final round table with all participants.

Participants are supported by four mentors who will follow them the entire path of the workshop. The workshop is activity that occupies the most hours and has the objective of providing the opportunity for a practical application of the theories set out in classroom and discussed in comparison between participants, tutors and teachers.

Conditions for participation and admission requirements:

The Summer School is addressed to the participation of a maximum of 30 students.

It is open to graduates and students of degree courses in Architecture or Civil Engineering, any field, coming from any of partners.

Will be allowed with priority 10 participants for each of the partner universities, ranked in chronological order of submission of applications accompanied by documentation.

Rank:

The selection of participants will be carried out according to a ranking compiled in chronological order of dispatch of documentation required, according with the suggested of 10 participants for each partner universities.
